all completed Outdoor Food Hygiene. All staff members hold current paediatric first aid certificates which are updated every 3 years.

- The Forest School Area is adjacent to the nursery site. A telephone and list of
  emergency contacts for staff and children are available in the nursery. The location of
  the nursery site (postcode and grid reference) is clearly displayed above the telephone in
  the office in the event of an emergency.
- Lit fires must be supervised at all times. The fire pit area is clearly marked with large logs. Children are not permitted to go inside the logs. There are low benches positioned around the fire at a safe distance for the children to sit on. Adults to teach children the rules for being around the fire and fire safety as ongoing learning opportunities.
- Safety talk with children at start of each session to discuss/remind about fire safety, not eating/touching plants (including mushrooms and fungi look but don't touch), boundaries, listening ears everybody listening song, following instructions, 1 2 3 where are you, etc. Forest School Leader to use flag poles to support the children to create their safe space and take ownership of boundaries.
- Ensure staff and children dress appropriately according to the weather conditions –
  waterproofs and wellington boots when it is raining, sun hats and sun cream when it is
  sunny. In adverse/severe weather conditions then area to remain closed staff to liaise
  with Manager/Deputy Manager to complete dynamic risk assessment.
- There are currently no big tree's growing in the forest school area, therefore, there is no risk of trees falling during high winds.
- Anti-bac gel for adults to clean hands. Wet wipes for children to wipe hands. Water at
  hand washing temperature is used from pump action flasks with hand soap and disposable
  blue roll. Staff and children also have access to hand-washing facilities in the setting.
- Toilet facilities available in the nursery building for adults and children. This includes a changing area, spare clothes etc if required.
- Individual children's food allergies are detailed on the Allergy List. A copy to be kept in travel first aid bag and checked before snack time/food preparation activities.
- Individual medication is kept onsite in the nursery building and is easily accessible if required. All high-risk medication such as Epi-pen and asthma pumps are stored in the first aid kit and kept in a safe place (container) at the onsite forest school area. All staff are aware of individual children's medical needs.
- Gardening tools and equipment is stored in the shed, which is kept locked at all times
  when not in use. Children are supervised at all times when using tools and equipment and
  adults teach them how to hold and use different tools correctly. Adult must count tools
  out and count in to ensure they are all returned and accounted for at the end of each
  session.
