## Statement of Intent

The Oasis Childcare Centres believe that children and parents are entitled to expect courtesy and careful, prompt attention to their needs and wishes. We welcome ideas and suggestions on how to improve our services and will give serious and prompt attention to any concerns that are raised about the running of the centre. We anticipate that most concerns will be resolved quickly by an informal approach to the appropriate member of staff. If this does not achieve the desired result then we have a set of procedures for dealing with concerns.

We aim to bring all concerns about the running of the centre to a satisfactory conclusion for all parties involved.

## Method

Should you have need for complaint, please contact Mrs Lorna Trudgeon (Senior Manager) or Mrs Juliette George (Senior Deputy Manager) in the first instance to arrange a meeting to discuss your concern in person. If the problem is not dealt with to your satisfaction, then please put your complaint in **writing** to the Chair of the Committee of The Oasis Childcare Centres.

Parent's views are respected and acknowledged. Appropriate and prompt action is taken on any concerns raised and complaints will be investigated. Complainants will be notified of the outcome within 20 days.
